New studies on global history require new empirical evidence and reflecting over the big questions such as why Europe industrialized faster than China or why modern science and capitalism did not emerge in China when it had all the conditions for this to happen. The way historians are systemizing the information of historical sources with the help of new technologies and creation of databases related to the questions to be answered constitutes the main issue of discussion in this workshop.

New methods and the use of western and eastern sources seem fundamental for scholars to carry on their case studies and collect data to make proper comparisons for the long and mid-run. The validity of historical sources and the quantification of data in long time series to analyse modern economic growth in China and Europe will be deeply discussed. Global history needs big data and the use of new technologies in the era of digital humanities results paramount for new case studies.
